# **VLovie LLC Payment Terms & Refunds**

VLovie LLC accepts Cash, Money Orders, Credit/Debit, Zelle, and Cash App.

All Credit / Debit payments are processed through Stripe or Chase & are subject to a NON - REFUNDABLE 4% fee.

ALL PAYMENTS ON SERVICES ARE NON - REFUNDABLE.

ALL PAYMENTS ON DIGITAL PRODUCTS ARE NON - REFUNDABLE.

ALL PAYMENTS ON *PHYSICAL PRODUCTS* are subject to a Non - Refundable 16% RESTOCK FEE [Indiana 7% Tax Fee | 4% Chase/Stripe Fee | 5% VLovie Stock & Delivery Fee]

Fees accumulated from services already tendered/ carried out/ or performed are **NON - REFUNDABLE.** 

All Payments are **NON - REFUNDABLE** (with Refund Exceptions that are in accordance to stated requirements and are at the discretion of VLovie LLC).

#### I. Taxes & Merchant Services

- A. VLovie LLC Taxes are a combination of Indiana State Sales Taxes and Merchant Service Fees.
- B. Indiana State Sales Tax: 7% (0.07%) on all physical/digital products
- C. Stripe: 2.9% + 0.30c (0.032%) on all credit/debit transactions
- D. Squarespace: 3% (0.03%) on all credit/debit transactions
- E. Chase Merchant Fee: \$0.40c (0.040%) on all credit/debit transactions

## II. Donations

- A. 100% of ALL proceeds of donations go to VLovie LLC and are distributed to its foundation, programming, development, and expansion.

- B. This donation is not a charitable donation and cannot be claimed as a charitable donation.

- D. You, the donator, and/or the consumer agree to this clause and agree to hold yourself responsible for any funds credited/debited to VLovie LLC as a donation.

E. You, the donator, and/or the consumer agree to not attempt to sue VLovie LLC for refunds of any one or multiple donations.

- I. No refunds on Business / Creative Services unless service was executed improperly and has caused undue hardship.
  - 1. Undue hardships may be in the form of fines, delays, or closures.
  - 2. Any refund issued will be at the discretion of the owner of VLovie LLC.
  - 3. Refund may not be the same as the total amount paid.

## VI. Refund Exceptions:

- A. Please send an email to Swines10@icloud.com for all refund inquiries, return items, or exchange items. Please type Refund/ Exchange in subject. You will be contacted on how to proceed.
- B. Send your item. Once your return is received and inspected, we will send you an email to notify you that we have received your email and/or return or exchange item and that it has been inspected. We will also notify you of the approval or rejection of your refund.
- C. If you are approved, then your refund will be processed, and a credit will automatically be applied through your original method of payment or to a VLovie LLC gift card. Refunds are processed within 10-15 business days not including individual bank processing times. Shipping costs are NON REFUNDABLE.
- D. If you haven't received a refund yet, first check your bank account again and the processes in which your institution processes payments and/ or contact your credit card

- company to check their payment processes. It may take some time before your refund is officially posted.

#### VII.Cancellations

#### A. Cancellation 25% Restock Fee is \$150.00 \* NOT INCLUDING INITIAL DEPOSIT

- B. If Michelle Boys Services are cancelled due to extreme weather conditions like a Tornado, Earthquake, Fire, Flood, or Hurricane, all services are to be rescheduled, not refunded, free of charge.
- C. If Michelle Boys Services are cancelled due to the signee/client becoming terminally ill, all services are to be **rescheduled**, **not refunded**, **free of charge**.
- D. If The Signee/ Client "calls off" their Session or Consultation a **25% Service Restock** will be applied to any and all fees; other wise **NO REFUND** will be rewarded.
- E. A new Business Consultation or Notary Signing Session can be rescheduled but it will **NOT** be free of charge and 25% Service Restock Fee

#### VIII. Miscellaneous Fees:

- A. **Revision Fee** \$50 for an hour appointment to make corrections to File.
- B. **Holiday Fee** \$50 additional for all appointments made on a Holiday Day or Weekend.
- C. **Reschedule Fee** \$50 additional for all appointments rescheduled within 24 HRS of scheduled appointment.
- D. **Overtime Fee -** \$50 for every hour over any scheduled time
  - 1. If Consultation or Session goes over scheduled time but is under 10 minutes, no fee will be applied.
  - 2. Any time over 10 minute grace period will be subjected to \$50 fine but the Client can receive a full hour {remainder of hour} of service.
